FREE SAVINGS ACCOUNT SERVICES OPENED IN THE BRONX WHERE NEARLY 60% LIVE IN ASSET POVERTY

RiteCheck Cash & Stash Program with Bethex Federal Credit Union Begins 2nd Year with Goal of Sextupling Savings Account Holders in NYCHA Communities

(BRONX, NY) January 26, 2015 – Today, RiteCheck, in cooperation with Bethex Federal Credit Union began their second annual free savings account drive at their Bronx Headquarters, helping thousands of working families across The Bronx and Northern Manhattan save for their futures. RiteCheck customers will be encouraged to open free savings accounts at RiteCheck stores in The Bronx this spring to start building savings towards their individual goals be it higher education, home improvements or critically needed emergency funds.

“RiteCheck is proud to partner with Bethex Federal Credit Union for our second annual Cash & Stash savings drive,” **Joseph Coleman, President of RiteCheck said.** “For nearly 60 years RiteCheck has served communities across The Bronx and Northern Manhattan working with families to prepare for the future. Our employees come from these communities and we are committed to the financial success of every Bronxite. Our Cash and Stash program has helped hundreds put savings towards their dreams and this year we hope to sextuple the number of account openings brightening the future for families across the city.”

“Nearly 60% of Bronx residents live in asset poverty – living without sufficient funds to survive above the poverty line for more than three months in the event of job loss or injury,” **Roman Vaccari, Executive Director of the Financial Service Centers of New York said.** “We are proud to support members like RiteCheck who recognize a need in a community and develop programs to fix them. We strongly encourage all Bronx residents to come in and sign up for a free savings account today.”

According to the Corporation for Enterprise Development’s (CFED) “Assets & Opportunity Profile: New York City” in conjunction with NYC’s Office of Financial Empowerment, **58.7% of households in the Bronx (13-40% more than residents of other boroughs) live in asset poverty**, meaning they don’t have sufficient assets to survive at the poverty line for three months in the absence of income. The free Cash & Stash savings accounts will help thousands build the emergency funds necessary for residents to survive on.

Last year, **RiteCheck’s program helped hundreds of residents across The Bronx, this year, the financial services center aims to sextuple that number and open more than a thousand savings accounts across the borough.** Applicants will only need \$5 to open an account and they can make deposits and withdrawals any time at any RiteCheck store. There are no credit checks and no turndowns and their money will be federally insured through the National Credit Union Administration (NCUA).

RiteCheck is a member of the Financial Service Centers of New York (FSCNY) the state trade association of licensed check cashers in New York.
